PAUL HURH is Assistant Professor in the Department of English at the University of Arizona. His essay “The Sound of Incest: Sympathetic Resonance in Melville’s *Pierre*” appeared in *Novel* in 2011, and his essay on William Faulkner’s *Abasalom, Absalom!* appeared in *Style* in 2008. In progress is a book-length study tentatively titled “American Terror: The Feeling of Thinking in Edwards, Poe, and Melville.”

UTTARA NATARAJAN, a Reader at the Department of English and Comparative Literature at Goldsmiths, University of London, is the author of *Hazlitt and the Reach of Sense: Criticism, Morals, and the Metaphysics of Power* (1998). She is editor of *The Hazlitt Review* and coeditor, with Tom Paulin and Duncan Wu, of *Metaphysical Hazlitt: Bicentenary Essays* (2005). Currently she is working on a monograph on the legacy of the Romantic essayists in Victorian fictional and nonfictional prose.

DAVID O’SHAUGHNESSY, a Leverhulme Early Career Fellow in English at the University of Warwick, has published widely on William Godwin, including his monograph *William Godwin and the Theatre* (2010) and his edition of *The Plays of William Godwin* (2010). He is coeditor, with Mark Philp and Victoria Myers, of *The Diary of William Godwin* (2010). He is working on a new book that examines Anglo-Irish cultural history as mediated in the work of Irish playwrights working in London 1750–1830.

CARA WEBER is a Doctoral Candidate at the Humanities Center, Johns Hopkins University. She is currently completing her dissertation, entitled “Marriage and Ethical Agency in Four Victorian Novels.”



ANN C. COLLEY is SUNY Distinguished Professor of English at the State University of New York College at Buffalo. Her most recent critical work is *Victorians in the Mountains: Sinking the Sublime* (2011), which contains a chapter on Robert Louis Stevenson. She is also the author of *Robert Louis Stevenson and the Colonial Imagination* (2004) and *Nostalgia and Recollection in Victorian Culture* (1998), which has several chapters on Stevenson. Most recently, her essay "Locating Home" appeared in Volume 8 of the *Journal of Stevenson Studies*.

NOAH COMET is Assistant Professor of English at the Ohio State University. His essay on Felicia Hemans appeared in *The Keats-Shelley Journal* in 2009, and an essay on Letitia Landon appeared in *The Wordsworth Circle* in 2006. In 2011 he edited a special issue of *Women's Studies* on nineteenth-century classicism, and is currently working on a book on Romantic Hellenism and women writers.

ALAN FISCHLER, Professor of English at Le Moyne College in Syracuse, New York, is the author of *Modified Rapture: Comedy in W. S. Gilbert's Savoy Operas* (1991) and of the chapter on Drama in the Blackwell *Companion to Victorian Literature and Culture*, edited by Herbert F. Tucker (1999). He has also published numerous articles on W. S. Gilbert and such nineteenth-century theater folk as Douglas Jerrold, James Planché, Dion Boucicault, and Madame Vestris.

MARTIN GRIFFIN is Associate Professor of English at the University of Tennessee, Knoxville. He is the author of *Ashes of the Mind: War and Memory in Northern Literature, 1865–1900* (2009). Currently he is working on an edited essay collection on American political fictions.

BRADLEY RAY KING is working on a Ph.D. in American Literature at the University of Texas at Austin. His dissertation historicizes Herman Melville's centrality to the disciplinary formations and fractures of twentieth-century American literary studies, examining how writers on the fringes of academia perform readings of Melville's writing to critique the exclusive hermeneutic practices of American literary studies and the democratic failures of American society more broadly.

JOHN B. LAMB, Associate Professor of English at West Virginia University, is the editor of *Victorian Poetry*. He has published essays on Thomas Carlyle in *Studies in Philology*, *Prose Studies*, *Victorian Institutes Journal*, *Victorian Newsletter*, *CLIO*, and *Carlyle Studies Annual*. He is now at work on an essay on the relation between authorship and the forms of government in Carlyle's *On Heroes*.

UPAMANYU PABLO MUKHERJEE, a Reader in the Department of English and Comparative Literary Studies at Warwick University, is the author of *Crime and Empire: The Colony in Nineteenth-Century Fictions of Crime* (2003) and *Postcolonial Environments: Nature, Culture and the Contemporary Indian Novel in English* (2010). His book “Natural Disasters” and *Victorian Imperial Culture: Fevers and Famines* is forthcoming from Palgrave Macmillan in 2013. Currently, in addition to completing the manuscript for this book, he is working on a number of essays.

VALERIE SANDERS, Professor of English at the University of Hull, is author of *The Tragi-Comedy of Victorian Fatherhood* (2009). She recently edited Margaret Oliphant’s *Literary Criticism, 1877–86* (2011), Part I, Volume 3 of the Pickering and Chatto edition of *The Selected Works of Margaret Oliphant*. She continues editorship of volumes in this edition, with Joanne Shattock and Joanne Wilkes.
